ORDER

In pursuance to the notification issued by the Department of Higher Education (Education-I Branch), Govt. of Punjab notification No HED-EDU10MISC/121/ 2022-5EDU/1/ 434672/ 2022 dated 28.09.2022, the Administrator, Union Territory of Chandigarh is pleased to adopt the same in respect of teachers and equivalent cadres in Govt. Colleges and Privately Managed Govt. Aided Colleges of U.T., Chandigarh as well as the deputationists from the State of Punjab w.e.f. 01.01.2016 on the same terms and conditions as mentioned therein subject to the following certain modifications:

- i) That the conditions of Service in case of teachers & equivalent cadre (U.T. Chandigarh) working in Govt. Colleges in UT, Chandigarh till 31.03.2022 shall remain unchanged and be regulated as per notification of Govt. of India, MHA dated 13.01.1992.
- ii) That the pay so fixed for the faculty in the revised pay scales on UGC pattern by the DDO concerned shall be got vetted/ verified from the SAS Account Functionaries of the Education Department before the drawl of salary in the revised scales of pay.
- iii) That Ministry of Home Affairs, Govt. of India vide its notification dated 29.03.2022 has made applicable the pay scales (UGC) w.e.f. 01.04.2022. Accordingly, in future, as and when the pay scales on UGC pattern are notified, the same will be made applicable to the teachers and equivalent cadres in the Govt. Colleges of U.T. Chandigarh by virtue of this notification and will have no concern with the Govt. of Punjab.
- iv) The revised pay on fixation w.e.f. 01.01.2016 as per notification dated 28.09.2022 of the Govt. of Punjab shall be admissible w.e.f. 01.10.2022. The decision to pay the arrears w.e.f. 01.01.2016 to 30.09.2022 on account of pay revision shall be taken separately in due course of time.
- v) That the revised pension to the retirees of UT, Chandigarh (teaching & equivalent cadres) retired during the period 01.01.2016 to 31.03.2022 shall be admissible w.e.f. 01.10.2022 on the pattern of Punjab Government retirees. The decision to pay the arrears w.e.f. 01.01.2016 to 30.09.2022 shall be taken separately in due course of time.
- vi) That the Allowances shall be the same as are applicable to the Punjab Government employees and are subject to adjustment subsequently switching over to the Central Pattern as per Govt. of India, MHA notification dated 29.03.2022.

- vii) That the employees shall exercise the option in the form appended as Annexure-III, within a period of two months from the date of adoption of the notification of Punjab Govt. dated 28.09.2022, by the Chandigarh Administration.
